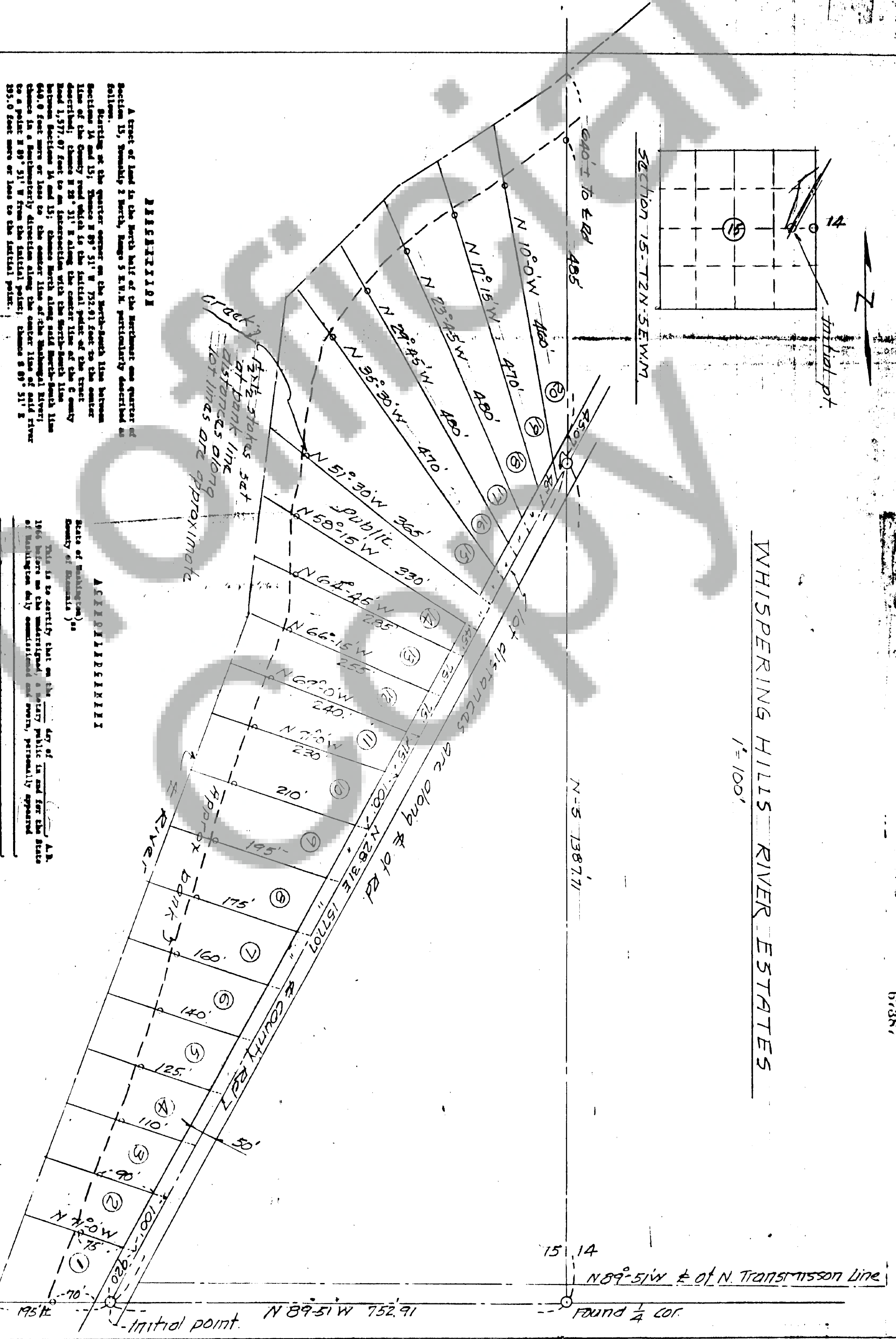


WHISPERING HILLS RIVER ESTATES

A tract of land in the North half of the Northwest quarter of Section 15, Township 2 North, Range 5 East, particularly described as follows:

Beginning at the quarter corner on the North-South line between Sections 14 and 15, thence N 89° 51' W 752.91 feet to the center line of the County road which is the initial point of the tract described; thence N 28° 31' E along the center line of the County road 1,577.97 feet to an intersection with the North-South line between Sections 14 and 15; thence North along said North-South line 440.0 feet more or less to the center line of the Washington River; thence in a southeasterly direction along the center line of said river to a point N 89° 51' W from the initial point; thence S 89° 51' E 335.0 feet more or less to the initial point.

REMARKS

That all men by whose presents that the foregoing corners of the land hereby platified, declare that plat and deed to be the use of the public forever all roads, streets, avenues and lanes as shown on this plat.

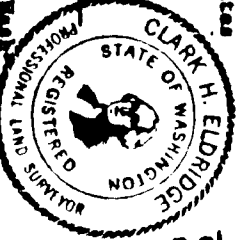
