Beginning at P.C. Station 15 + 65.95 which lies 894.26 feet North and 133.57 feet West from the N.W. Corner of the Henry Shepard D.L.C. # 43; thence following a 10° 00' curve to the left 232.17 feet; thence N 9° 51' E 705.73 feet to Station 25 + 03.85 being the P. C. of a 10° 00' curve to the left; thence following said 10° 00' curve 282.33 feet to P.T. Station 27 + 86.18; thence N 18° 23' W 259 feet more or less to the North line of the N.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of Section 36, Township 3 North, Range 7 E.W.M.

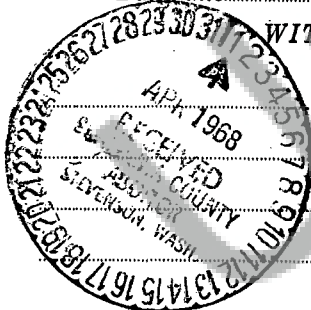
