

DEED OF ADMINISTRATRIX

THE GRANTOR, as Administratrix of the Estate of Walter A. Wilcox, deceased, having received the final payment under a Land Contract dated July 11, 1950, signed by Walter A. Wilcox, as Seller, and Elva M. Sooter, as purchaser, and the Court having authorized the Administratrix to execute a Deed conveying the property to Elva M. Sooter upon receipt of the sum of Five Thousand Two Hundred Ninety-nine and 36/100 (\$5,299.36) Dollars, and the Administratrix having received said sum, now, therefore, the Grantor, Margaret L. Suckow, as Administratrix of the Estate of Walter A. Wilcox, deceased, for and in consideration of the balance due on the Land Contract in the amount of Five Thousand Two Hundred Ninety-nine and 36/100 (\$5,299.36) Dollars, in hand paid, does bargain, sell and convey unto the Grantees, Howard E. Sooter and Elva M. Sooter, as joint tenants with right of survivorship and severability as at common law; as provided in RCW 64.28.010, all of the rights, title and interests of said estate to the following described real estate situated in the County of Skamania, State of Washington, to-wit:

The North Half of the Northeast Quarter of the Northeast Quarter; the North Half of the North Half of the South Half of the Northeast Quarter of the Northeast Quarter; and the Northwest Quarter of the Northeast Quarter, ALL in Section 22, Township 3 North, Range 10, east, W. M.,

EXCEPT the following described tract of land:

Beginning at a point 218 feet east of the quarter corner on the north line of said Section 22; thence along said north line east 462 feet; thence south 220 feet; thence west 462 feet; thence north 220 feet to the point of beginning.


