Commencing at a point 44.9 ft. North & 381.7 ft. West of the 1/4 corner on the East line of Sec. 15, T4N, R7E, W.M., and running thence S. 43° 54' E. 392.8 ft.; thence S. 57° 54' E. 658.5 ft.; thence S. 83° 26' E. 350.0 ft.; thence S. 11° 00' W. to the center line of Wind River a distance of approximately 480 ft.; thence in a Northwesterly direction along the said center line of Wind River to a point which is located S. 52° 00' W. of the point of beginning approximately 120 ft.; thence N. 52° 00' E. approximately 180 ft. to point of beginning; the above described tract being subdivided into lots numbering from 1 to 23 inclusive according to the attached plat hereof.
