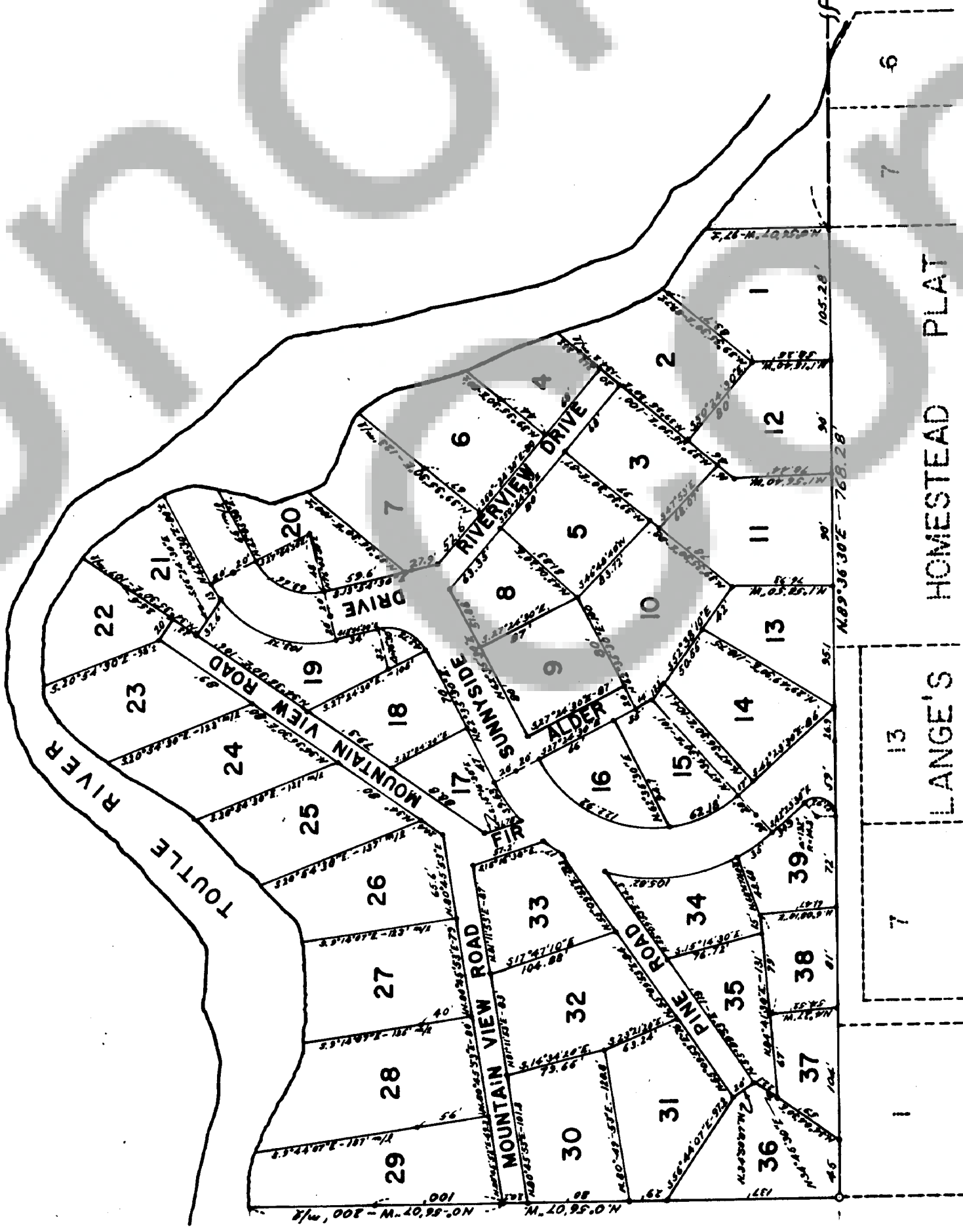


PLAT OF SPIRIT LAKE VIEW LOTS

SKAMANIA COUNTY, WASHINGTON



DESCRIPTION

Beginning at a point lying 92.38 feet North and 676.56 feet West of the Quarter Section Corner common to Sections 15 and 16, Township 9 North, Range 5 East, Willamette Meridian; said point lying on the South Bank of the Toutle River; thence, in a Northwesterly direction along said South Bank of the Toutle River to a point lying 456.27 feet North and 1,450.87 feet West of aforementioned Quarter Section Corner; thence, South 0° 56' 07" East, a distance of 466.2 feet, more or less, to the Northwest Corner of the plat of Lange's Homestead, on file in the Auditor's Office of Skamania County, Washington; thence North 89° 36' 30" East, along the North line of the plat of Lange's Homestead, a distance of 768.28 feet; thence, North 0° 56' 07" West, a distance of 97 feet, more or less, to the point of beginning.

DEDICATION

Know all men by these presents that the undersigned owners in fee simple of the land hereby platted, declare this plat and dedicate to the use of the public forever all roads, streets, avenues, places and sewers easements or whatever public property there is shown on the plat and the use thereof for any and all public purposes not inconsistent with the use thereof for public highway purposes, also the right to make all necessary slopes for cuts and fills upon the lots, blocks, tracts, etc., shown on this plat in the reasonable original grading of all the streets, roads, avenues, places, etc., shown hereon. Also the right to drain all streets over and across any lot or lots where water might take a natural course after the street or streets are graded.
