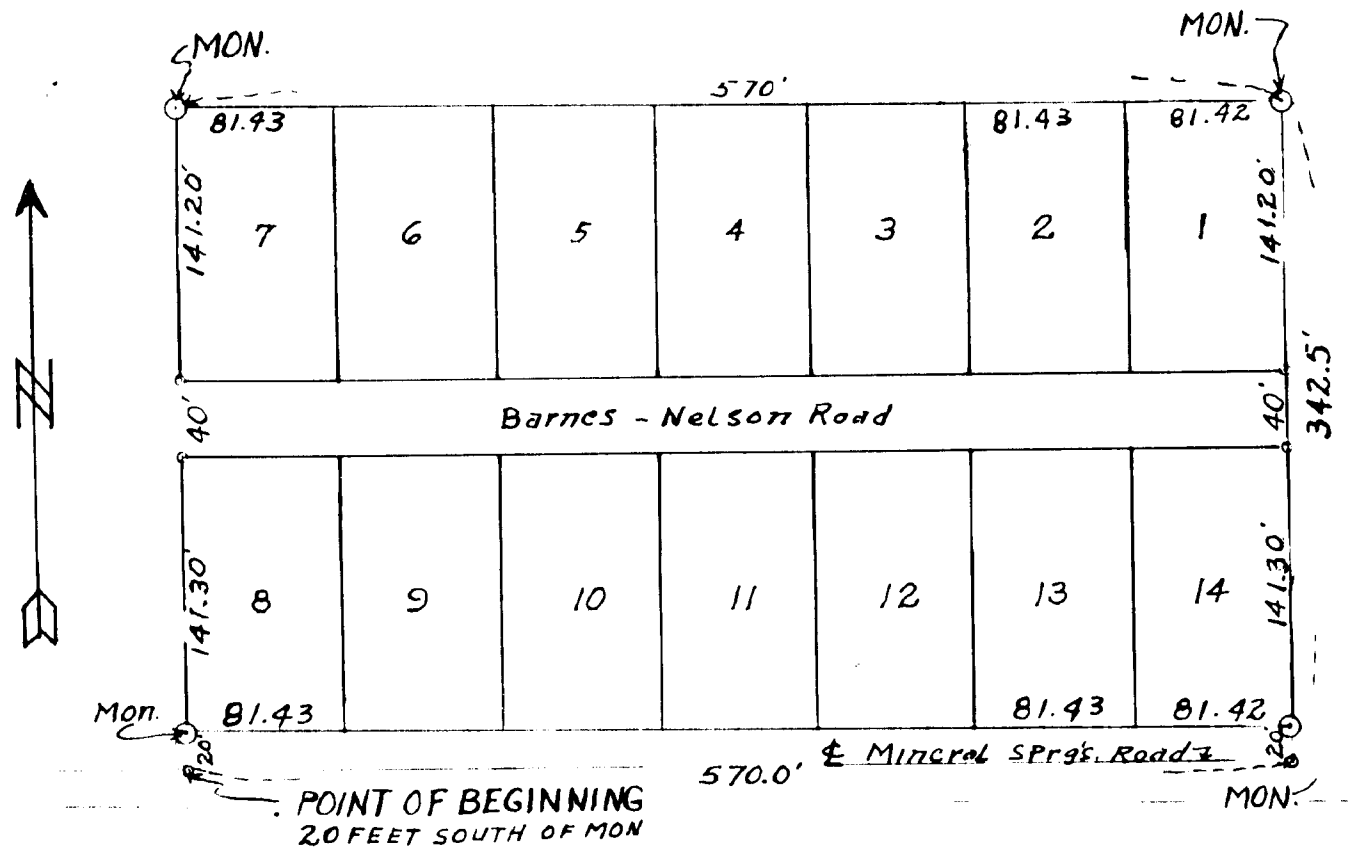


CHESTER R. NELSON SUBDIVISION

DESCRIPTION

Commencing at the Southwest Corner of the N.W. 1/4 of the S.W. 1/4 Section 21 Township 3 North, Range 8 E. W. M. Thence North 1680.00 feet; Thence East 430.67 feet to the true point of beginning marked as noted on plat. Thence from true point of beginning East 570.0 feet. Thence North 342.5 feet. Thence West 570.0 feet. Thence South 342.5 feet to point of beginning. Excepting a 40 foot wide road running East and West through the center of tract as shown on plat, which was previously deeded to Skamania County as recorded Book 48 of Deed, page 482

DEDICATION

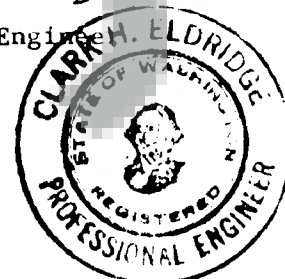
RESERVATIONS
