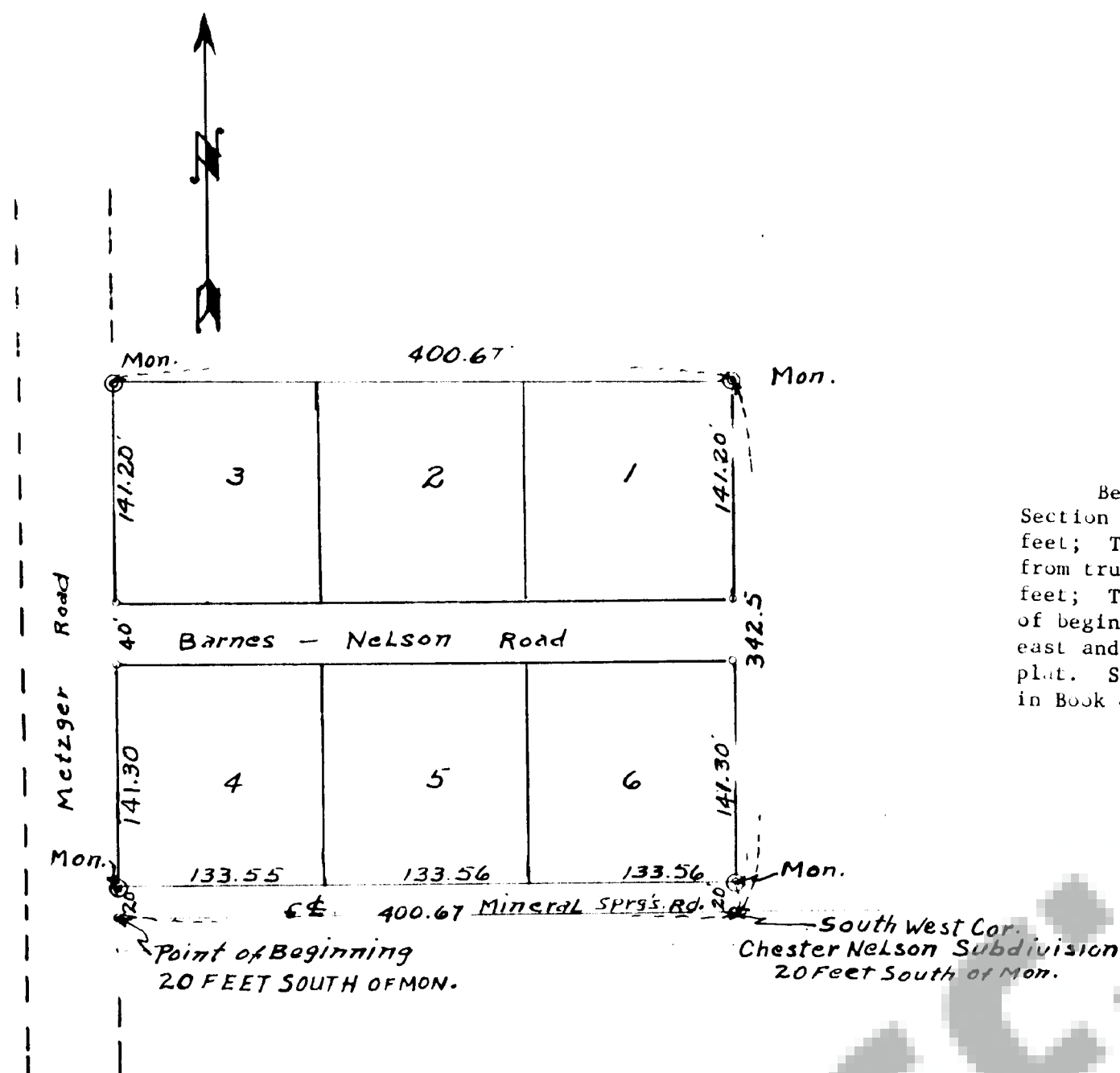


ROBERT W. BARNES SUBDIVISION

DESCRIPTION

Beginning at the Southwest corner of the N.W. 1/4 of the S.W. 1/4 Section 21 Township 3 North, Range 8 E.W.M. Thence North 1680.00 feet; Thence East 30.0 feet to true point of beginning. Thence from true point of beginning East 400.67 feet; Thence North 342.5 feet; Thence West 400.67 feet; Thence South 342.5 feet to point of beginning. Except a 40 foot Right of Way for County Road running east and west through the center of described tract as shown on plat. Said Right of Way being recorded in Office of County Auditor in Book 48 of Deeds, page 506.
