A bill of Sale From Chenoweth to D F Bradford

This Indenture mad and entered into this the 4th day of November A.D. 1862 by and between F A Chenoweth and Elizabeth A Chenoweth his wife of County of Walla Walla Washington Territory party of the first part and Daniel F Bradford and P F Bradford of the (Cascades Skamania County W.T.) party of the second part witnesseth that the said party of the first part for and in consideration of the sum of one Thousand (\$1000) Dollars to them in hand paid by the said party of the second the right whereof is hereby admitted have bargained. Sold and conveyed and by these presents do bargain sell and convey unto the said party of the second part and their heirs forever the Right of Way across the Donation Land Claim of the said party of the first part. Situated at the Cascades Skamania County Washington Territory the said right of way being confined to that portion of said claim over which the Railroad Track is now laid and on over and Through (40) feet of Land on each side of said Track. Together with all and singular the priviledges necessary to enjoy the same for Railway Purposes.

And further give to the said parties of the second part the Right to cut and use all timber upon said claim which may be necessary to complete said RailRoad and also the right to cut and remove any trees in addition to those above stated which may be growing upon said claim not exceeding However Three Hundred (300) in number and the said parties of the second part hereby agree to value and discharge the said party of the second part from any and all claims which they may have against the said party of the second part growing out of any trees already cut or cut & removed by the said party of the second part.

Bill of Sale From T.J. Perkins to Julian Bush

Cascades W.T. Feb 10th 1863

Know all men by these presents greeting that I T. J. Perkins do give barter and assign my right and title to the following described property to Julian Bush for the sum of \$500.00 Five hundred dollars to wit. Twenty head or ten yoke of Oxen marked as follows. First yoke near one white, Red neck off sm white branded B- 2nd yoke near one spotted off one red mottly face branded B. 3d yoke near one spotted Red and White shouther off one red mottly face brand B. 4th yoke near one spotted off one spotted linedbacked branded B. 5th yoke near one reddised lined back off one red branded B 6th yoke near one brindle stare in the forehead off one spotted red and white branded B. 7th yoke near one red and white mottly red branded B off one red branded (CC) 8th yoke near one dun colorbranded BB. off one red mottly faced branded B. 9th yoke near one Red-sided lineback off one roan branded B. 10th yoke near one spotted off one lineback sides dun color.
