Bradford of Cascades as aforesaid the receipt whereof is hereby acknowledged do hereby remise release and forever quit claim unto the said Daniel F. Bradford his heirs and assigns all my right title and interest in and to a certain tract or parcel of land Situate lying and being in said Cascades and known as the land claim of said Daniel F. Bradford for a more particular description of which reference may be had to the notification of said Daniel F. Bradford number One Hundred and sixty One on file in the Surveyor Generals office in Olympia in said Territory and being all the interest in said land Claim according to me by said Daniel F. Bradford to me dated February twenty third A.D. 1855. And recorded in the registry in said Skamania County in Book A Pages 9 and 10 to have and to hold the above released premises with all the privileges and appurtenances thereto belonging to the said Daniel F. Bradford his heirs and assigns to his and their use and behoof forever, and I the said Putman F. Bradford for myself and my heirs Executors and administrators, do covenant with the said Daniel F. Bradford his heirs and assigns that the premises are free from all incumbrances made or suffered by me- and that I will and my heirs executors and administrators shall warrant and defend the same to the the said Daniel F. Bradford his heirs and assigns forever against the lawful claims and demands of all persons claiming by, through. or under me- but against no other. In witness whereof I the said Putman F. Bradford have hereunto set my hand and seal this twenty Eighth day of April in the year of our lord Eighteen Hundred and fifty six.
