This conveyance is intended as a mortgage, to secure the payment of a certain promissory note, now held by the party of the second part, given by the party of the first part for the sum of One Hundred dollars (\$100 00), dated the twelfth day of December last past, and payable to Chas A Braden or bearer six months from date thereof in gold coin or its equivalent, with use, and if the amount of the said note, principle, and interest shall be paid at maturity: Then these presents shall become void, and the estate hereby granted, shall cease, and utterly determine: But if default shall be made in the payment of the said sum of money, or the interest, or of any part thereof, at the time herein before specified for the payment thereof, the said party of the first part, in such case doth hereby authorize, and fully empower, the said party of the second part, his heirs, executors and administrators, and assigns, to sell the said hereby granted premises at public auction, and convey the same to the purchaser, in fee simple agreeable to the act, in such cases made and provided, and out of the money arising from such sale, to retain the principle and interest, which shall then be due on the said note, together, with all costs and charges, and pay the surplus (if any) to the said party of the first part, their Heirs, Executors, administrators or assigns.

Know all men by these presents, that we, Isaac H. Bush, and Julia Ann Bush his wife, for, and in consideration of the sum of Four Thousand Dollars, in Gold Coin of the United States, to us in hand paid by Putnam F. Bradford, have bargained and sold, and by these presents, do bargain, sell, and convey, unto the said Putnam F. Bradford, each for ourselves jointly and severally, as well in the relation of Husband and wife, as in our several individual rights, all our rights title and interest, in, and to the following described property, lying and being in Skamania County Washington Territory, and lying and being at the Cascades of the

Columbia River in said County, and known and described and designated as the Donation Claim of Isaac H. Bush, and his wife Julia Ann Bush.

And in consideration of the sum aforesaid, we do hereby, grant bargain, sell, and quit claim, unto the said Putnam F. Bradford, all our right title and interest, in any lands tenements and hereditaments in Skamania County Washington Territory, which we may have by virtue of any act of Congress of the United States granting Donations to actual settlers upon the Public lands of the United States, or by purchase from any person or persons, and all the interest title and possession, which we may have in the Donation Claim aforesaid as well by purchase, as under any Act of the Congress aforesaid, and all our interest in the property aforesaid, as well in law as in equity.

To have and to hold the same unto the said Putnam F. Bradford, and his heirs, forever, together with all the rights, franchises, and appurtenances thereto belonging and appertaining, with all the improvements thereon, giving unto the said Putnam F. Bradford, peaceable possession of the same, and covenanting for ourselves, and heirs, not to disturb him in the peaceable, and quiet enjoyment of the same.

Deed from P.F.Bradford & wife to Cascade Rail Road Company.

Know all men by these presents, that we, Putnam F. Bradford and
Helen Bradford, wife of the said Putnam F for and in consideration of the sum
of One Hundred and Five Dollars received to our full satisfaction of the Cascades
Rail Road Company a corporation organized under the laws of Washington
Territory, have bargained, sold given and granted, and do hereby bargain sell,
give and grant unto the said Cascade Rail Road Company, all that tract or lot of
land privileges, easements, and appurtenances which were conveyed to the said
Putnam F Bradford by a deed bearing date the 17th day of September 1862 made by
Cornelius J Palmer, which deed is recorded on the 120th & 121st pages of Book
A of the Records of Skamania County, Washington Territory, Reference being had
to said deed and to the record thereof, for a more full and perfect description
of the premises intended to be conveyed.

To have and to hold with the appurtenances thereunto belonging
unto the said Cascade Rail Road Company, and its assigns, to its and their own
use and benefit forever. And I the said Putnam F Bradford for my self, my heirs,
executors, and administrators, do hereby covenant, to, and with the said Cascade
