Imans of Skamania County and Territory of Washington, in consideration of the sum of one hundred and fifty dollars to me paid by Justin Chenowith of the county and Territory aforesaid, the receipt whereof is hereby acknowledged, do hereby convey, remise, release and forever quit claim unto the said Chenowith, his heirs and assigns, a certain lot or parcel of land situate in said county aforesaid at the upper end of the Cascades Portage with all the buildings thereon standing, bounded and described as follows Viz; being one hundred and sixty six feet in width in front, along the line of fence-posts, now thereon standing, by one hundred and fifty in depth at right angles thereto, and being the lot purchased from Daniel F. Bradford and resided upon by me in the year 1856, with all the rights, easements, privileges, and appurtenances thereto belonging.

To have and to hold the above released premises, to the said Chenowith his heirs and assigns to his and their use and behoof forever.

And I the said Iman for myself, and my heirs, executors and administrators do covenant with the said Chenowith his heirs and assigns, that the premises are free from all incumbrances made or suffered by me, and that I will, and my heirs executors, administrators shall warrant and defend the same to the said Chenowith, his heirs and assigns forever against the <sup>claims and demands of all persons</sup> lawful claiming by through or under me, but against none other.
