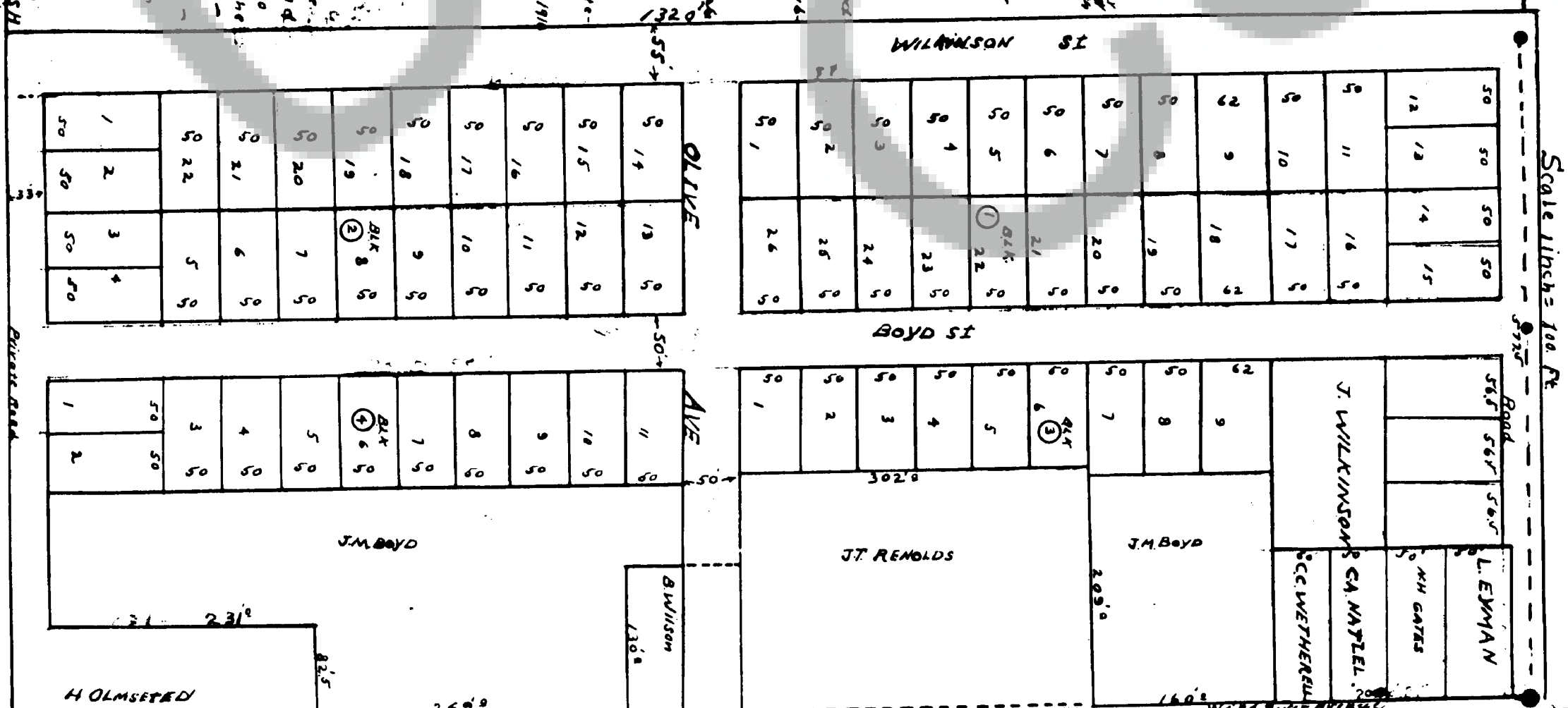

Commencing at the N.E. corner of NW 1/4 of N 8 1/2 Sec. 29, T. 3 N. R. 8 W. 11. Thence survey west 577.51 to intersection of center of Williamson Street, thence South 1320', back 199' to Southeast corner of said land, thence South 89° 56' back to back boundary of said land, thence North 269.91 to South corner of A. Wilson land, thence 101' North to North boundary of Oliver Ave. Thence 302' to corner of J. M. Boyd, and north, thence 160' North and east for North east corner of track 209.2' by 160.0', thence 225' to point of beginning; meeting satisfactory closely for said track.

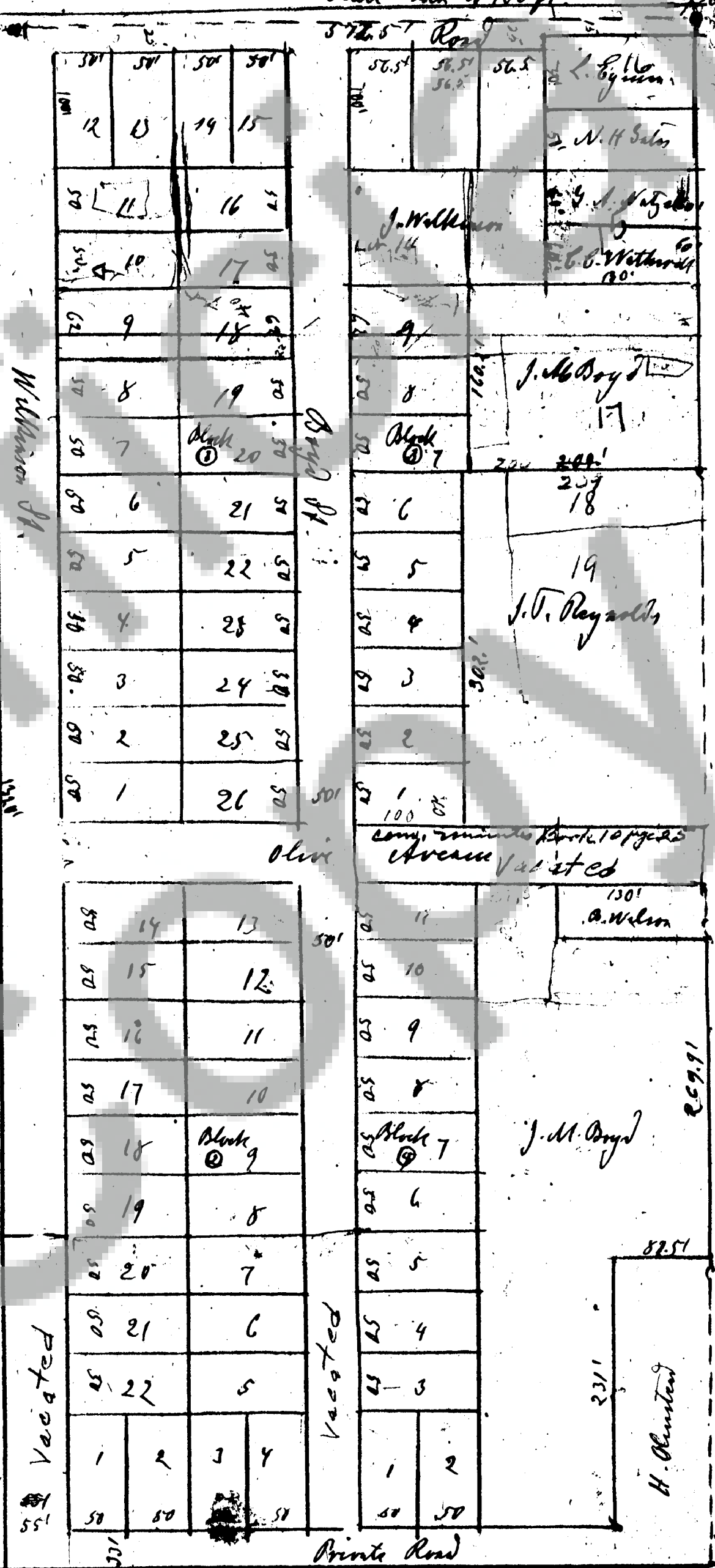

Commissioners' minutes of May 7, 1934 shows in part as follows: "Therefore, it is ordered that the following described portions of Boyd & Wilkinson Addn according to official plat thereof in Book 'A' of Plats, page 36: lots 1 to 7, inclusive, and lots 20 to 22, inclusive, Block 2; lots 1 to 5, inclusive, Block 4; also that portion of Boyd Avenue commencing at the north line of lot 5, Block 4 and lot 1, Block 2, southwesterly to the South boundary of said plat; also that street or road designated as Williamson Street and that street or road designated as private road, be and the same hereby is vacated and annulled and that portion of the streets and roads included therein, west in the owners of the real property and lots contiguous thereto in this manner provided by law."
