

Know all men by thest presents that we Isaac H Bush and Juliann Bush Husband and Wife of the county of Skamania in the Territory of Washington for and in consideration of the sum of Fifteen Thousand dollars to us paid by the Cascade Rail Road Company a corporation under the Laws of said Territory have given and granted bargained and sold and do hereby give grant bargainsell convey<sup>and</sup>/quitclaim unto the said the said Cascade Railroad company Their successors and assigns the following described Property and the Right of way for a Rail Road across over and through our entire donation Land Claim in said county, Said right of way to be where said Rail Road no commensed on said claim has been constructed or surveyed or as near thereto as can be consistent with the most Judicious construction and completion of said Road, Said Right of way to bee and extend in width Thirty feet each way from the center of the Rail Road track that is now or shall be laid in the construction of said Road together with one or more buildings at suitable convenient points on the Columbia River is desired by said company.

To have and to hold the said Right of Way unto the said Cascade Rail Road Company's successors and assigns with all the privileges and appertinances thereunto belonging and all Right and privileges nessary and for free and full completion Enjoyment of said Right of way for ever

And we the said Isaac H. Bush and Julian<sup>Push</sup> do hereby expressly covenant and agree that all Right and title that we own have or from the United States or any other sourse may hereafter acquire to said Right of Way shall ensure to the benefit of and bee vested in said Cascade Rail Road Company and Successors And assigns as fully as could bee by any deed executed by us after the acquisition of such title and we do hereby acknowledge satisfaction for full damages heretofore suffered or claimed by us of either of us for or on account of any work done in construction of said Rail Road on our said donation claim And hereby release damage for the same or for any future claims against Persons whatsoever
