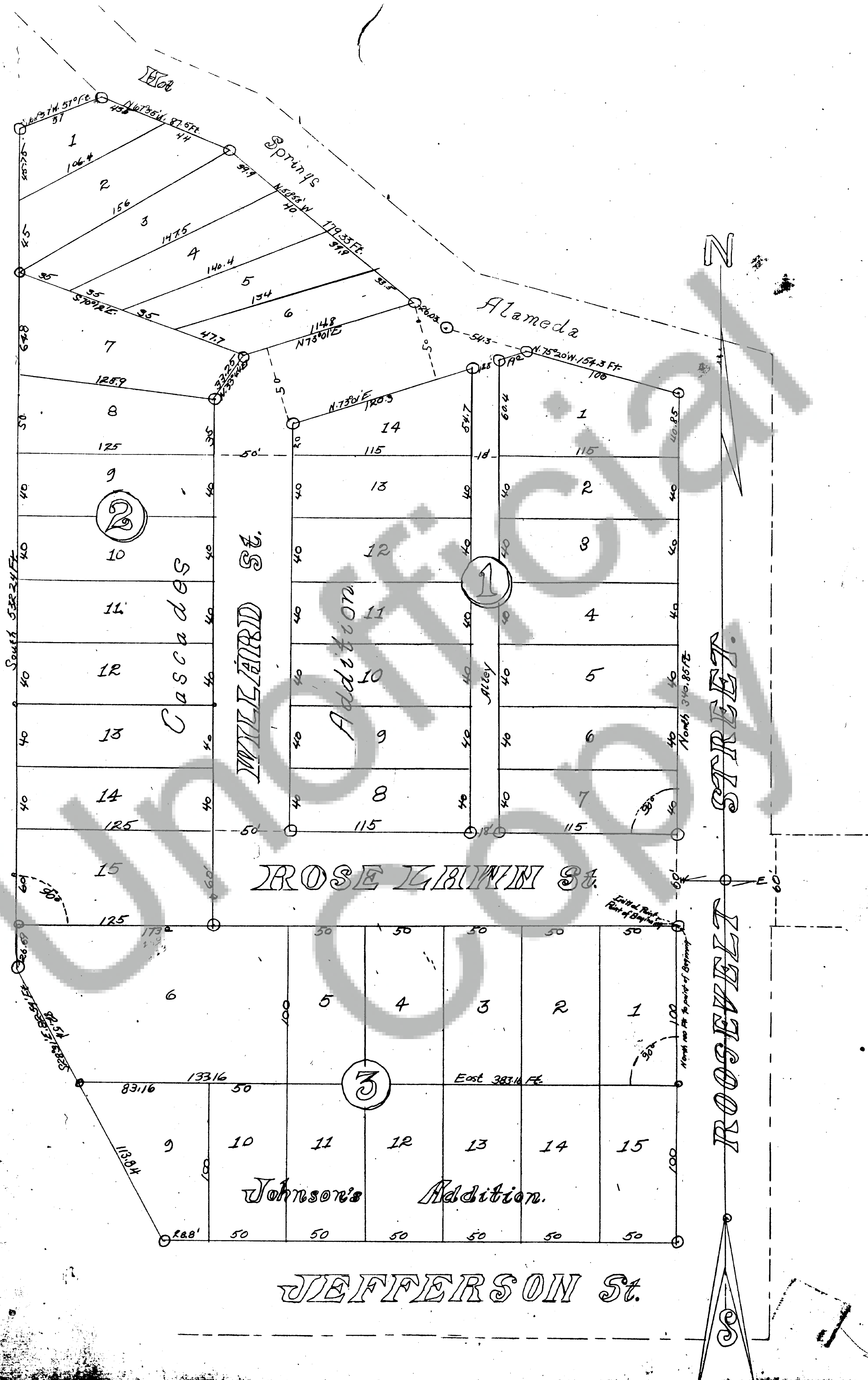




Plat & Description of Cascades & North One half of Block *3 of Johnsons Add.

Beginning at the Initial point, on the North-East corner of Block *3 of Johnsons Addition to the town of Stevenson, Washington, the line bears North 0°00' West 340.85 Ft. distance, Thence North 75°20' West 154.3 Ft., Thence North 50°58' West 179.33 Ft., Thence North 67°55' West 87.6 Ft., Thence South 68°57' West 57.2 Ft., Thence South 0°00' East 532.24 Ft., Thence South 28°31' East 82.54 Ft., Thence East 383.16 Ft., Thence North 100.2 Ft., to the point of beginning.
