Bush, in the hearing of all the bystanders, I am about to sell the following tracts of real estate, (and then read the ~~XXXXXXXXXXXX~~ foregoing description of said real estate which was contained in the notices of sale) upon the following execution (and then read the said execution) and I then stated the amount I was required to make upon said execution, which amount included damages, interest, and costs up to the day of sale, and increased costs, and I the said Sheriff then enquired who will pay the debt for seven years care of the entire tract of land, and there being no bidder, and no person offering to pay the debt for a seven years lease of the entire tract of land, or any part thereof, I the said Sheriff then enquired who will pay the debt for the entire tract of land, and one Dennison offering to pay the debt, for the entire tract of land, I then enquired who will pay the debt for the least quantity of land, whereupon John Catlin offered to pay the debt for 500 acres, whereupon Julia Ann Bush offered to pay the debt for 499 acres and I then enquired will any person pay the debt for less than 499 acres of land, and no person offering so to do I sold to the said Julia Ann Bush the said 499 acres of land, she being the best bidder therefor for the sum of one hundred and ninety dollars, the balance due upon said execution, which sum of money, the said Julia Ann Bush then paid to me: Said 499 acres of land to be taken from the north east corner of said tract of land, levied upon by me as aforesaid in a square form as near as may be.
