Bush, and Julia Ann Bush of, in, to, the said land and the appurtenances thereof.

to have and to hold the same unto the said Julia Ann Bush her heirs, and assigns, to her and their only proper use and behoof forever according to the laws and usages of this Territory in such cases made and Provided.
