Thence W. on the north boundary of said claim, about 76.00 chains to the N.W. corner of said claim: Thence S on the west boundary of said claim 9.09 chains. Thence on a straight line to a post on the bank of the Columbia River marked D B and F.G.I. Thence up the Columbia River at low watersmark to the place of beginning, containing one hundred and sixty seven and a half acres more or less.
