Washington, witnesseth, that the party of the first part for and in consideration  
of the sum of one hundred dollars cash, to them paid, the receipt whereof is hereby,  
acknowledged, have bargained, sold, aliened released, conveyed and confirmed, and  
by these presents do bargain sell, alien release, and convey and confirm unto the  
said party of the second part, his heirs, and assigns, forever, all their right title  
and interest, to a certain piece of Land described as follows,

The North East quarter, of the North East quarter, and lots Nos, one  
two and Three in section Nos Thirty five and lot Nos Three in Section No Thirty  
Six, of Township No Two North of Range No Six, East of the Willamette Meridian,  
Containing One Hundred and Thirty Three, and, Fifty hundredths (133.50) acres,  
and described in Certificate No ninety nine and Notification No Fourteen Hundred  
and Seventy Three, on file at the Registers and Receivers office at Vancouver  
Washington Territory, together with all the tenements, hereditaments, and
