Memorandum of an agreement, made and entered into this the 16th day of March A.D. 1868, by and between F.G. Imans, party of the first part, of Skamania County, Washington Territory, and the Dalles Lumber and manufacturing company, of Dalles City, Wasco County Oregon party of the second part. Said agreement is as follows, to wit. These parties above mentioned, agree to enter into copartnership, to be known and designated, as the Rock Creek Lumber Company, for the purpose of manufacturing all kinds of lumber to supply the Dalles and any other market, for the term of two with the privilege of four years from the time of starting the mill, and agree to bind themselves, to faithfully to carry out the following conditions, for the following consideration

The party of the first part agrees to furnish for said company as follows, His Mill site, water powers, Mill frame, so far as already finished, all timber, and lumber, belonging to, and intended for his new Saw Mill, situated on his land claim and near the mouth of Rock Creek, together with all his Mill tools blacksmith tools such as saws, axes, picks shovels and shop room, for the same. Also further agrees to furnish, on the stump any and all saw timber that may be wanted for manufacturing purposes (except his Oak timber) with the privilege of selecting the same from any part of his land claim at the rate of fifty cents (50cts) pr thousand feet, and further agrees to furnish, any and all shafting that he may have on hand, together with boxes and pulleys, that may be needed in putting the mill into operation, and further agrees, at the end of said term, of years, to pay said second party, the cost of all the improvements including Dams. Flooms, Ditches, Buildings, machinery, and all other expenses of putting into operation said mill & machinery, agreeing to apply on such payment, the amount
