G. Iman for the sum of \$1325 78/100 and 597 07/100 Costs and interest to date making in all the sum of \$1922.25 at this date and all sum and sums of money, that may be had, or obtained by means thereof together, with the said judgement, hereby constituting and appointing the said Dalles Lumber/Company, my true and lawful attorney, irrevocable, with power of substitution and revocation for their use, and at their costs, and charges, to take all lawful ways and means for the recovery the money due, or to become due on said judgement, and on payment to acknowledge satisfaction of, or discharge the same. Hereby ratifying, and confirming all that my said Attorney or their substitute shall lawfully do or cause to be done by virtue hereof.
