Leavens of the County of Multnomah in the State of Oregon, the receipt whereof is hereby acknowledged by these presents, give, grant, bargain, sell, and convey unto the said Hiram A Leavens, the following described lot, or parcel of land, situate in the County of Skamania and Territory of Washington, and More particularly described as follows,- to wit- Lot No Five (5) of Section No Twenty Five (25) and the East Half of the South East Quarter of Section No Twenty Six (26) in Township No Two (2) North of Range No Six (6) East. And the North East Quarter of the North East Quarter, and Lots One (1) Two (2) and Three (3) in Section Thirty Five (35) and Lot Three (3) in Section Thirty Six (36) all in Township two, (2) North of Range Six (6) East. (230½ Acres)

To have and to hold the above granted premises, with the privildges, and appurtenances, thereto belonging to the said Hiram A Leavens, his heirs and assigns, to their own use and behoof forever. And we, the said John D Woodward and Sarah C Woodward, for ourselves and our heirs, executors, and administrators and assigns, do covenant with the said Hiram A Leavens, his heirs, and assigns, that we are lawfully seized in fee, of the afore granted premises, that they are free, from all encumbrances. That we have good right to sell, and convey the same, to the said Hiram A Leavens, as aforesaid, and that we will, and our heirs, executors, and administrators shall and do forever Quit claim the same to the said Hiram A Leavens, his heirs and assigns, forever.
