Now know ye, that the United States, of America, in consideration of the premises, and in conformity with the provisions of the Act aforesaid, Have given and Granted, and by these presents, Do give and Grant unto the aforesaid Samuel M. Hamilton and to his heirs, the East Half, and unto his wife, the said Mary Jane Hamilton, and to her heirs, the West Half, of the tract of land above described, To have and to hold the said tract with the appurtenances unto the said Samuel M Hamilton and his wife Mary Jane Hamilton, and to their heirs, and assigns forever, their respective, portions as aforesaid.
