W.T. holding terms at Vancouver.

Agreement made and entered into on this 28th day of October A.D. 1872,
between the Dalles Lumbering, and Manufacturing Company, of Wasco County State of
Oregon, the party of the first part, and F.G. Iman, the party of the second part,
Witnesseth, that whereas on the first day of November A.D. 1867, in the United
States District Court, of the 2nd Judicial District, holding terms at Vancouver
W.T. a judgement was rendered in favor of Amos Underwood, and against F.G. Iman
A. P. Minear and Thomas Smith, in a suit where said Underwood was Plaintiff and
Said last named parties were defendents for the sum of Thirteen Hundred, and Twenty
Five dollars, and Eighteen Cents (\$1325.18) and costs, and disbursements therein
taxed, and whereas said Amos Underwood, on the 24th day of March 1869, for a valuable
consideration, duly sold, and assigned according to law said judgement, to the
said Dalles Lumbering, and Manufacturing Company, the party of the first herein, and
whereas, the lien of said judgement will expire on the first day of November A D
1872 as provided in the Statues of Washington Territory. Now therefore, and because
of the premises, and to the end that the lien of said judgement, may not expire on
the said first day of November 1872 but may continue in full force and effent it
is hereby expressly agreed, and stipulated by the said Parties of the first,
and second that said judgement rendered on the first day of November A D 1867, be,
and the same is hereby revised on, and from the first day of Nov 1872, and that the
said judgement so rendered at said day shall be and continue, a lien in the real
estate of said defendent, to said judgement for the period of five years from and
after the said first day of November A.D. 1872.
