That said Rowe Lumber and Manufacturing Company by F. H. Rowe its managing Agent, employed said E. M. Jarvis to perform such labor and render such assistance, upon the following terms and conditions to wit:

The said Rowe Lumber

and Mowry advertising Company, by and through
T. H. Rose its managing agent, Incorporated
Said E. M. Faris is to furnish
such labor and receive such
assistance, Twenty $\$20$ ⁰⁰ dollars
per month and board
and lodging.

That said contract has been
faithfully performed and
fully complied with on the
part of the said E. M. Faris
who performed labor and
assisted in securing and man-
ufacturing said lumber
for the period of forty days.

That said labor and assistance were
so performed and rendered upon
said lumber between the 78th
day of July 1896 and the 13th
day of September 1896 and the
quotation of said services
was closed on the 13th day
of September 1896, and thirty
days have not elapsed since
that time. That the amount
of claimants demand for
said services is \$30 $\frac{73}{100}$, that
no part whereof has been paid,
except First $\$100$, dollars and
there is now due and remaining
unpaid thereon, after deducting
all just credits and offsets,
the sum of Twenty-Eight $\frac{73}{100}$
 $\$28\frac{73}{100}$, Dollars in which
amount he claims a lien upon
said lumber


