Iman his wife of Cascades Skamania County Washington Territory parties of the first part for and in consideration of the sum of One Thousand Dollars Gold Coin of the United States of America to us in hand paid the receipt whereof is hereby acknowledged have this day sold bargained, delivered and conveyed, and by these presents do sell bargain deliver and convey unto Simeon Geil of Cascades Skamania County Washington Territory, party of the second part, and to his heirs administrators and assigns all that certain portion, Peices or parcels of land, Situated, lying and being in Skamania County Washington Territory, bounded and described as follows, "To wit" Being the whole interest of the parties of the first part to a certain Donation Land Claim Number of Certificate One Hundred and Sixty Three (163), Notification No 838, and known and designated in the Surveys and Plats of the United States as Claim No Forty four in Township No Two, North of Range No Seven East of the Willamette Meridian and particularly bounded and described as follows, To wit- Beginning at the North East Corner of Section No Two and running thence South, Twenty Three chains and Twenty links Thence West Twenty chains and Fifty links Thence South Twenty chains and Fifty Five links, Thence North Fifty Four and one half degrees.
