

Loggers Lien of Jonathan E Rawson

Jonathan E Rawson, claimant.

vs

The Washougal Land and Logging Company
(a corporation)

Notice is hereby given that Jonathan E. Rawson of Skamania County, State of Washington, claims a lien upon a lot of fir saw-logs, being about 2,200,000 feet in quantity, and a lot of hemlock logs, being about 500,000 feet in quantity, which were cut or manufactured in Skamania County, State of Washington, the fir logs being marked thus "S" on end and "W" on side and the hemlock logs thus "H" on end and "V" on side of each log, and said fir and hemlock logs are now lying in the Washougal River, in that part of said part of said river lying and being in Township number two, north of Range five east of the Willamette meridian, in said Skamania County, being between the Washougal Land and Logging Company's dam in said river and the chute therein and in and near said dam, and in said river as aforesaid and scattered along said river in the woods for labor performed upon and assistance rendered as fireman on engine in logging camp used in pulling and hauling said logs out of the woods, and obtaining and securing said saw-logs and logs; that the name of the owner or reputed owner is the Washougal Land and Logging Company (a corporation); that the Portland Savings Bank, and O. N. Senny as

Receiver of the Portland Savinier's Bank, of Portland, Oregon, have, or claim to have, some interest therein; that the said Washougal Land and Logging Company, by its duly authorized and constituted president, manager and agent, J. A. Buckley, employed said Jonathan E. Rawson to perform such labor and render such assistance upon the following terms and conditions, to-wit:

The said Washougal Land and Logging Company, by its said duly authorized and constituted president, manager and agent, J. A. Buckley, agreed to pay the said Jonathan E. Rawson for such labor and assistance the sum of \$26⁰⁰ per month and furnish board and lodging free of charge; that said contract has been faithfully performed and fully complied with on the part of the said Jonathan E. Rawson, who performed labor upon and assisted in obtaining and securing said saw-logs and logs for the period of 66 days; that said labor and assistance were so performed and rendered upon said saw-logs and logs between the 15th day of June, 1895, and the 10th day of September, 1895; and the rendition of said service was closed on the noonday of September 9, 1895, and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is \$66⁰⁰; that no part thereof has been paid except \$2²⁵, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$63⁷⁵, in which amount he claims a lien upon said saw-logs and logs. The said Jonathan E. Rawson also claims a lien on all said saw-logs and

logs now owned by said Washougal Land and Logging Company of said county, the said Portland Savings Bank, and the said O. Denny as Receiver of the said Portland Savings Bank, and each of them, to secure payment for the work and labor performed in obtaining or securing the said saw-logs and logs herein described.

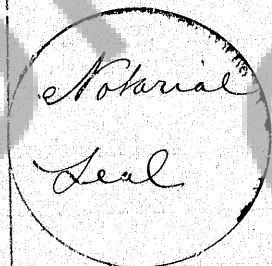
