From J. D. Woodward & wife to H. Leavens & Thomas Pierce.

This indenture made the Seventeenth day of June, in the year of our Lord, One Thousand, Eight Hundred and Sixty Five, between John D. Woodward of Skamania County Washington Territory, and Sarah, his wife of the first part, and H. A. Leavens, and Thomas Pierce, of Multnomah County, in the State of Oregon, of the second part Witnesseth. That the said parties of the first part, for, and in consideration of the sum of Two Hundred, and Twenty Five Dollars, lawful money of the United States to them in hand paid, the receipt whereof is hereby acknowledged, have granted, bargained, sold, aliened, released, conveyed, and confirmed, and by these presents do grant, bargain sell, alien release, convey, and confirm unto the said parties of the second part and to their assigns, forever, all that certain lot or parcel of land, situate, lying, and being in the County of Skamania, in the Territory of Washington, to wit,- The North East Quarter of the North East Quarter, and Lots No One (1) Two (2) and Three (3) in Section No Thirty Five (35) and Lot No Three (3) in Section No Thirty Six (36) of Township No Two (2) North of Range No- Six (6) East of the Willamette Meridian, and Lot No- Five (5) of Section No- Twenty Five (25) and the East half of South East Quarter, of Section No- Twenty Six (26) in Township No- Two (2) North of Range No- Six (6) East, containing Two Hundred and Thirty Acres, and fifty Hundredths of an acre, together with, all and singular the hereditaments, and appurtenances, thereunto belonging, or in any wise appertaining and the reversion, and reversions, remainder and remainders, rents, issues, and
