That the said parties of the first part for and in consideration of the sum of One Hundred Dollars to them paid in hand, by the party of the second part at or before the en sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have remised, released, and quit claim unto the said party of the second part and to his heirs and assigns forever.

All that certain parcel of land, situated in the County of Skamania, in the Territory of Washington and bounded and described as follows, to wit, Beginning at a rock on the north bank of the Columbia River, at the South East Corner of William M. Murphys, donation land claim, described in his notification No 837 thence North Sixty (60) chains ^{to a stake; thence West twenty seven (27) chains} to Wind River, Thence South to the Columbia River Thence up stream by the meanders of the Columbia River to the place of beginning, the same being my donation land claim, containing One Hundred and Sixty Acres.
