

R. L. Correll vs E. B. Williams et al

Notice is hereby given that R. L. Correll of Skamania County, State of Washington, claims a lien upon the franchise, earnings and all the real and personal property of E. B. Williams, which is used in the operation of his said saw mill, lumber and timber business, in Skamania County, Washington, to the extent of the moneys due him, from said E. B. Williams, operating said franchise or business, for labor performed in and about said E. B. Williams' saw mill as hereinafter set forth.

That the said property of the said E. B. Williams upon which the claimant herein claims a lien is situated as follows, to-wit: Upon a certain wooden building — feet by — feet in size, situated on the North west quarter of Section thirty five, Township three North, Range seven East, Willamette Meridian, in Skamania County, Washington, and used as a sawmill building by the said E. B. Williams; also upon the steam boiler and engines, sawmill machinery, pulleys, belting, shafts, saws, chains, tools and any and all machinery and tools connected with or in any manner used in and about the said sawmill building, so situated as aforesaid; also upon any and all lumber, timber or ties of whatever nature or description now lying and being in the mill yard of said sawmill.

This lien is claimed for work and labor performed and assistance rendered by the claimant for the said E. B. Williams as Engineer, in the operation of said sawmill, lumber and timber business, in Skamania County, Washington.

That the name of the owner or reputed owner is E. B. Williams, and Thomas Connell has a claim to have some interest as owner therein.

That said E. B. Williams, by F. B. Clark, his agent, and manager, employed said R. L. Correll, to perform such labor and render such assistance on the following terms and conditions, to-wit:

That the said E. B. Williams, by and through F. B. Clark,

his agent and manager, agreed to pay said R. L. Correll, for such labor and assistance the sum of \$2⁰⁰ per day for all work and labor performed.

That said contract has been faithfully performed and fully complied with on the part of the said R. L. Correll, who performed labor in and about said sawmill for the period of 35 days.

That said labor and assistance were so performed and rendered in said sawmill between the 25th day of April, 1900, and the 30 day of May, 1900, and the rendition of said services were closed on the 30th day of May, 1900, and ninety days have not elapsed since that time. That the amount of claimant's demand for said services is \$Seventy (\$70⁰⁰) dollars, that no part thereof has been paid, except Twenty-three ³⁵/₁₀₀ (\$23.35) Dollars, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of Forty-six ⁶⁵/₁₀₀ (\$46.65) Dollars, in which amount the claimant herein claims a lien upon the property of the said E. B. Williams hereinbefore fully described.
