Notice is hereby given that E. L. Hollar of Skamania County, State of Washington, claims a lien upon the franchise, earnings and all the real and personal property of E. B. Williams, which is used in the operation of his said sawmill, lumber and timber business, in Skamania County, Washington, to the extent of the money due him from said E. B. Williams, operating said franchise or business, for labor performed in and about said E. B. Williams' sawmill as hereinafter set forth.

That the said property of the said E. B. Williams upon which the claimant herein claims a lien is situated as follows, to-wit: Upon a certain wooden building — feet by — feet in size, situated on the North west quarter of Section thirty five, Township three North, Range seven East, Willamette Meridian, in Skamania County, Washington, and used as a sawmill building by the said E. B. Williams; also upon the steam boiler and engines, sawmill machinery, pulleys, belting, shafts, saws, chains, tools and any and all machinery and tools connected with or in any manner used in and about the said sawmill building, so situated as aforesaid; also upon any and all lumber, timber or ties of whatever nature or description now lying and being in the mill yard of said sawmill.

This lien is claimed for work and labor performed and assistance rendered by the claimant for the said E. B. Williams, as Cut-off sawyer, in the operation of said sawmill, lumber and timber business, in Skamania County, Washington.

That the name of the owner or reputed owner is E. B. Williams and Thomas Connell has or claims to have some interest as owner therein.

That said E. B. Williams, by F. B. Clark, his agent, and manager, employed said E. L. Hollar, to perform such labor and render such assistance on the following terms

and conditions, to wit:

That said C. B. Williams, by and through C. L. Hollar, his agent and manager, agreed to pay said C. L. Hollar, for such labor and assistance the sum of \$2.⁰⁰ per day for all work and labor performed.

That said contract has been faithfully performed and fully complied with in the part of the said C. L. Hollar, who performed labor in and about said saw-mill for the period of 17 days.

That said labor and assistance were so performed and rendered in said saw mill between the 8th day of May, 1900, and the 30 day of May, 1900, and the rendition of said services were closed on the 30 day of May, 1900, and ninety days have not elapsed since that time. That the amount of claimant's demand for said services is \$Thirty-Four (\$34.⁰⁰) Dollars; that no part thereof has been paid, except Seventeen (\$17) Dollars, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of Seventeen (\$17) Dollars, in which amount the claimant herein claims a lien upon the property of the said C. B. Williams hereinbefore fully described.
