E. C. Stone, Claimant

and

J. D. Crawford, Defendant.

Notice is hereby given that E. C. Stone of Skamania County, State of Washington, claims a lien upon a lot of fir cordwood and timber sawed for cordwood, here of about 250 cords of timber sawed for cordwood and 450 cords of fir cord wood in quantity, which was cut or manufactured in Skamania County, State of Washington, are marked thus - no mark, and 150 cords of said wood are now lying in the South East Quarter of the South East quarter of Section Twenty-four, Township three North, Range seven East of the Willamette Meridian, 150 cords thereof are now lying in Lots five and eight in Section Twenty-four, Township three North, Range seven and a half East of the Willamette Meridian, and also about 150 cords thereof are now lying in or near the wharf on the Columbia River in Lot thirteen in Section Twenty-six, Township three North, Range seven and a half East of the Willamette Meridian. All of the above being in Skamania County, Washington.

Also 250 cords of timber sawed for cord-wood now lying in South East Quarter of the South East Quarter of Section 24, Township three North, Range Seven East of the Will. Mer. in Skamania County Washington, for labor performed upon and assistance rendered in manufacturing and securing said cordwood and timber sawed for cord-wood; that the name of the owner or reputed owner is J. D. Crawford; that J. D. Crawford employed said E. C. Stone to perform such labor and render such assistance on the following terms and conditions, to wit:

That said J. D. Crawford agreed to pay the said, E. C. Stone for such labor and assistance 50 cents per cord for sawing said timber sawed for cord wood and 30 cents per cord for hauling cordwood and \$3.00 per day for 2 $\frac{1}{2}$ days hauling in securing said cordwood. That said contract has been faithfully performed and fully complied with on the part of said E. C. Stone, who performed labor upon and assisted in manufacturing and hauling and securing said cord wood and timber sawed for cordwood.

That E. C. Stone sawed 250 cords of timber sawed for cordwood and hauled 249 cords of cord wood and hauled in said cordwood for the period of 2 $\frac{1}{2}$ additional; that said labor and assistance were as performed and rendered on said cordwood and timber sawed for ordwood between the 3rd day of January, 1900 and the 28th day of June, 1900, and the rendition of said service was closed on the 28th day of June, 1900, and thirty days have not elapsed since that time; that the amount of claimants' demand for said service is \$207.20 dollars; that no part thereof has been

paid except \$80.00 and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$124.20, in which amount he claims a lien upon the said cordwood and timber saved for cordwood. The said E. C. Stone also claims a lien on all said cordwood and timber saved for cordwood now owned by said J. D. Crawford of said County and State to secure payment for the work and labor performed in obtaining or securing the said cordwood and timber saved for cordwood herein described.
