Notice is hereby given that S. S. Richards of Skamania County, State of Washington, claims a lien upon a lot of fir cordwood and sawed timber for cordwood, being about 350 cords in quantity, which was cut or manufactured in Skamania County, State of Washington, are marked thus - no mark, and are now lying in the south east quarter of the south east quarter of Section twenty-four, Township three North, Range seven East of the Hillarrette Meridian. All of the above being in Skamania County, Washington. for stimpages on said cordwood and sawed timber for cordwood; That the name of the owner or reputed owner is J. D. Crawford; That J. D. Crawford purchased the timber from which said cordwood - sawed timber for cordwood from S. S. Richards on the following terms and conditions, to-wit:

That said J. D. Crawford agreed to pay the said S. S. Richards for stimpage for said timber from which said wood was cut for the sum of 10 cents per cord, that said contract has been faithfully performed and fully complied with on the part of said W. A. Simko, who furnished the timber for said cordwood and said sawed timber for cordwood.

That said S. S. Richards furnished the timber to said J. D. Crawford for 800 cords of fir wood during the period of seven months; That said cordwood and sawed timber for cordwood was furnished and cut between the 1st day of September, 1900, and the 23rd day of June, 1901, and the furnishing of said timber and the cutting of the same was closed on the 23rd day of June, 1901, and thirty days have not elapsed since that time; That the amount of claimant's demand for said stimpage is Eighty Dollars; That no part thereof has been paid except --- and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$80.00, in which amount he claims a lien upon the said cordwood and timber sawed for cordwood. The said S. S. Richards also claims a lien on all said wood now owned by said J. D. Crawford of said County and State to secure payment for the stimpages furnished for obtaining or securing the said wood herein described.
