GENERAL LAND OFFICE BY THE SURVEYOR GENERAL:

NOW KNOW YE, THAT THERE IS, THEREFORE GRANTED BY THE UNITED STATES UNTO THE SAID DAVID ROSS THE TRACT OF LAND ABOVE DESCRIBED: TO HAVE AND TO HOLD THE SAID TRACT OF LAND, WITH THE APPURTENANCES THEREOF, UNTO THE SAID DAVID ROSS AMD TO HIS HEIRS AND ASSIGNS FOREVER; SUBJECT TO ANY VESTED AND ACCRUED WATER RIGHTS FOR MINING, AGRICULTURAL, MANUFACTURING, OR OTHER PURPOSES, AND RIGHTS TO DITCHES AND RESERVOIRS USED IN CONNECTION WITH SUCH WATER RIGHTS, AS MAY BE RECOGNIZED AND ACKNOWLEDGED CUSTOMS, BY THE LOCAL LAWS, AND DECISIONS OF COURTS, AND ALSO SUBJECT TO THE RIGHT OF THE PROPRIETOR OF A VEIN OR LODE TO EXTRACT AND REMOVE HIS ORE THEREFROM, SHOULD THE SAME BE FOUND TO PENETRATE OR INTERSECT THE PREMISES HEREBY GRANTED, AS PROVIDED BYLAW.

IN TESTIMONY WHEREOF I, BENJAMIN HARRISON, PRESIDENT OF THE UNITED STATES OF AMERICA, HAVE CAUSED THESE LETTERS TO BE MADE PATENT, AND THE SEAL OF THE GENERAL LAND OFFICE TO BE HEREUNTO AFFIXED.
