

Location Certificate of Tunnel Golconda by Henry B. & J.

To all whom these presents may concern:
 Know ye that we, Henry B. & J. Citizens of the United States, of Milwaukee, State of Wisconsin and Paul Ludloff a Citizen of Toledo, Lucas County, State of Washington do hereby declare and publish as a legal notice to all the world that we have a valid right to the occupancy, possession and enjoyment of the Golconda tunnel and Tunnel Site, located August 2nd 1896 for the discovery of Mines and the development of lode, and strata in Copper mining District, Skamania County, State of Washington, described as follows, to-wit:

Mouth of Tunnel situate on southwestern slope of the high mountain range in the uppermost part of North Toulle river valley and North of the same in a small gulch opening to the southward of Samson basin, in a North eastern branch of North Toulle River valley, about one quarter of a mile South-East of Camp Samson and about one mile South from the divide between Samson basin and Quetz Park valley.

The Golconda tunnel and Tunnel Site, located August 2nd 1896 by Henry B. & J. and Paul Ludloff courses South 45° East magnetic 3000 feet to end post from mouth of tunnel. Size of tunnel 6 feet by 6 feet. Beginning at the mouth of tunnel and running $S 45^{\circ} W$ 750 feet post is set marked N W corner of Golconda tunnel claim, thence $S 45^{\circ} E$ 3000 feet post is set marked S W corner of Golconda tunnel claim, thence $N 45^{\circ} E$ 750 feet post is set marked Center Stake on South end line of Golconda tunnel claim 3000 feet $S 45^{\circ} E$ from mouth of tunnel; Thence $N 45^{\circ} E$ 750 feet post is set marked S E corner of Golconda tunnel claim, thence $N 45^{\circ} W$ 3000 feet post is set marked N E corner of Golconda tunnel claim, thence $S 45^{\circ} W$ 750 feet to mouth of the tunnel and point of beginning.

From the mouth of the Tunnel running $S 45^{\circ} E$ 500 a stake marked center stake on Golconda tunnel line 500 feet $S 45^{\circ} E$ of mouth of tunnel, at 1000 feet a stake is set marked center stake on Golconda tunnel line 1000 feet $S 45^{\circ} E$ of mouth of tunnel, at 1500 feet a stake is set marked center stake on Golconda tunnel line 1500 feet $S 45^{\circ} E$ of mouth of tunnel. At 2000 feet a small fir is cut off and stumps marked center stake on Golconda tunnel line 2000 feet $S 45^{\circ} E$ of mouth of Tunnel. At 2500 feet stake is set marked center stake on Golconda tunnel line 2500 feet $S 45^{\circ} E$ of mouth of tunnel. At 3000 feet center stake on South end line of

Galeonda tunnel claim is struck previously described from where a fire 30 inches diameter is $N 75^{\circ} W$ $4\frac{1}{2}$ feet distant. The fire 18 inches diameter is $N 81^{\circ} E$ 7 feet distance.

Further to debar to take any bearings to natural objects. Both lines marked P.T. And we claim for line of tunnel 750 feet on each side of the center of the bore or course of the tunnel, and the right to all lodes which may be discovered in the due prosecution of said tunnel within 750 feet on each side of the center of said line. We also claim a square tract of land 125 feet on each side of the mouth of the tunnel and extending 250 feet immediately below the mouth of the tunnel, as stated upon the ground for dumping purposes, together with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining, and all rights granted to the locator as tunnel rights under the terms of Section 2323 of the Revised Statute of the United States.
