

Tony Gregor vs. James Campshell & wife

Notice is hereby given that I claim a lien on a certain box frame dwelling house, 18 by 24 feet in dimensions and one and a half stories high situated and being in Barron in Skamania County, Washington and about 200 feet south of what is called Barron Hall. That claimant commenced to work on said house in the construction thereof on the 28th December, 1903, and ceased working on the 29th December 1903, having worked two days on said house at wages of two dollars a day, and ninety days have not since closed; that James Campshell employed me to work on and in the construction of said house and agreed to pay me two dollars a day and said James Campshell & wife then were and now are the owners of said house - wherefore I claim and have a lien on said house for the sum of four dollars for and on account of said work on said house and the further sum of six dollars costs, charges & expenses incurred in preparing, filing and recording this lien. This lien and my said claim is assigned to Nicholas Gregorius.

Joseph Gregorius vs. James Campshell and Campshell, his wife
Mechanics Lien.

Plaintiff claims a lien for twelve and $\frac{30}{100}$ \$12.307 Dollars on and against a certain Box frame dwelling house eighteen (18) by twenty-four (24) feet in dimensions and one and a half stories in height situated and being on the land and premises of one A. C. Eastabrook about two hundred (200) feet south from Barron Hall in Barron in the County of Skamania in the State of Washington; said claimant is and at all times mentioned in this claim was a carpenter by trade and occupation and, as such carpenter, he was, by said James Campshell employed on or about the 8th December 1903, to construct and build and aid in the construction and building of said box frame dwelling house and said land and premises at the rate and wages of thirty (30) cents an hour and as much as his work was reasonably worth for each and every hour he should work in such construction of said house, that in pursuance

of said employment said claimant commenced to work and labor on and in the construction of said house on the 10th Day of December, 1903, and ceased to work and labor thereon on the 29th Day of December, 1903, and during and between said dates, worked and labored on said house in the construction thereof, as such Carpenter, and as such employment, forty-one (41) hours at such rate of thirty (30) cents an hour, that said James Campbell and his said wife, at the times aforesaid when and when said work and labor were performed by this claimant, were and now are the owners and requested owners of said house, said claimant hereby claims the sum of Twelve and $\frac{30}{100}$ (\$12.30) Dollars from said James Campbell and his said wife, for and on account of said labor, that claimant's work was reasonably worth 30 cents an hour; that said sum of money or any part thereof has not been paid, though duly demanded, and that this claimant hereby claims and establishes a lien, pursuant to the statutes of the State of Washington, on said dwelling house for the said sum of Twelve and $\frac{30}{100}$ Dollars for said labor and work and the further sum of six Dollars expenses incurred in preparing, filing and recording this lien; and claimant further says that thirty (30) Days have not elapsed since the cessation of said work and labor. I hereby assign this lien and my claim to Nicholas Gregorius.
