WHEREAS, THERE HAS BEEN DEPOSITED IN THE GENERAL LAND OFFICE OF THE UNITED STATES A CERTIFICATE OF THE REGISTER OF THE LAND OFFICE AT VANCOUVER, WASHINGTON, WHEREBY IT APPEARS THAT, PURSUANT TO THE ACT OF CONGRESS APPROVED 20TH MAY, 1862, "To Secure Homesteads to actual Settlers on the Public Domain," AND THE ACTS SUPPLEMENTAL THERETO, THE CLAIM OF NAOMA S. BISHOP, WIDOW OF LIVI C. BISHOP, DECEASED HAS BEEN ESTABLISHED AND DULY CONSUMATED, IN CONFORMITY TO LAW, FOR THE

FRACTIONAL NORTHWEST QUARTER OF SECTION SEVENTEEN IN TOWNSHIP TWO:

NORTH OF RANGE FIVE EAST OF WILLAMETTE MERIDIAN IN WASHINGTON, CONTAINING ONE
HUNDRED AND FIFTY-NINE ACRES AND FIFTEEN HUNDREDTHS OF AN ACRE.

ACCORDING TOETHE OFFICIAL PLAT OF THE SURVEY OF SAID LAND, RETURNED TO THE
GENERAL LAND OFFICE BY THE SURVEYOR GENERAL.

NOW KNOW YE THAT THERE IS, THEREFORE, GRANTED BY THE UNITED STATES UNTO THE SAID NAOMA S. BISHOP THE TRACT OF LAND ABOVE DESCRIBED: TO HAVE AND TO HOLD THE SAID TRACT OF LAND WITH THE APPURTENANCES THEREOF, UNTO THE SAID NAOMA S. BISHOP AND TO HER HEIRS AND ASSIGNS FOREVER; SUBJECT TO ANY VESTED AND ACCRUED WATER RIGHTS FOR MINING, AGRICULTURAL, MANUFACTURING, OR OTHER PURPOSES, AND RIGHTS TO DITCHES AND RESERVOIRS USED IN CONNECTION WITH SUCH WATER RIGHTS AS MAY BE RECOGNIZED AND ACKNOWLEDGED BY THE LOCAL CUSTOMS, LAWS, AND DECISIONS OF COURTS, AND ALSO SUBJECT TO THE RIGHT OF THE PROPRIETOR OF A VEIN OR LODE TO EXTRACT AND REMOVE HIS ORE THEREFROM, SHOULD THE SAME BE FOUND TO PENETRATE OR INTERSECT THE PREMISES HEREBY GRANTED, AS PROVIDED BY LAW, AND THERE IS RESERVED FROM THE LANDS HEREBY GRANTED, A RIGHT OF WAY THEREON FOR DITCHES OR CANALS CONSTRUCTED BY THE AUTHORITY OF THE UNITED STATES.

IN TESTIMONY WHEREOF, I WILLIAM MCKINLEY, PRESIDENT OF THE UNITED STATES OF AMERICA, HAVE CAUSED THESE LETTERS TO BE MADE PATENT, AND THE SEAL OF THE GENERAL LAND OFFICE TO BE HEREUNTO AFFIXED.
