Know all men by these presents, that I Simeon Geil of Cascades Skamania County, Washington Territory, Party of the first part, for and in consideration of the sum of One Dollar, to me in hand paid and other valuable considerations, the receipt whereof is hereby acknowledged, have this the twenty second day of October in the year of Our Lord, One Thousand Eight Hundred and Seventy Seven have sold, bargained, delivered and conveyed, and by these presents do sell, bargain, deliver, and convey, unto Margaret W. Iman of Cascades, Skamania County Washington Territory and to her Heirs administrators, and assigns all that certain Piece or parcel Of Land, lying and being in Skamania County Washington Territory being the Donation Land Claim of Felix G. Iman and Margaret W. Iman, and bounded and described as follows, "To Wit" Being Known and designated, on the survey, and Plats of the United States as Claim No Forty Four, in Township No Two, North of Range No Seven, East of the Willamette Meridian and Particularly bounded and described as follows " To Wit " Beginning at the North East Corner of Section No Two and running thence South, Twenty Three Chains and Twenty links. Thence, West Twenty Chains and Fifty links , Thence South, Seventy Chains Fifty Five links, Thence North Fifty Four and One half Degrees Forty one Chains and Twenty Five links. Thence North Seventy one chains, and Thirty Seven links, and thence East Fifty Four Chains, to the place of beginning, Containing Three Hundred and Twenty Three and Twent y Four Hundredths, (323.24) Acres.

Also one other certain piece of land, being a portion of the Donation Land Claim formerly owned by Daniel Baughman and more particularly described as follows, To wit. Laying and being in Skamania County Washington Territory, and beginning on the Bank of the Columbia River, at the South East Corner, of the Donation Land Claim of the said Daniel Baughman. Thence North about nine chains, to the North East corner of said claim, Thence West, on the North boundary of said claim about seventy Six chains, to the North West corner of said claim. Thence South on the West boundary of said claim 9.09 chains. Thence on an straight line to a Post on the Bank of the River, Marked D B & F G I . Thence up the Columbia River at low water mark to the place of beginning. Containing One Hundred and Sixty Seven, and One Half Acres more or less.

To have and to hold all and singular the above premises unto the said Margaret W. Iman her Heirs, administrators and assigns the above bargained, and described premises, together with all the tenements, Hereditaments and Appurtenances thereunto belonging or in any wise appertaining, together with all the rents, issues and profits, thereof to her and their own use and behoof forever. And I do further agree to warrant and defend the title to the same against all parties claiming, by, through, or under me, but against none other.
