For the Hercules Lode S 82 W owned by K. Ludloff at least One Hundred Dollars for trail work from Grizzly Creek to that place has been expended.

For the Mt Hood Lode N 45 W owned by K. Ludloff and A. Wold on this side, claim there has been expended at least One Hundred Dollars on trail from Grizzly Creek passing the claim and leading to Union Basin. For Norway. Claim N 15 W

One side claim owned by K. Ludloff at least One Hundred and Twenty five Dollars has been expended.

For Union Basin Claims, For these claims there has been expended the sum of at least Twenty three hundred Dollars. Owing to the fact that a syndicate of Eastern and English capitalist did not fulfil the obligation at the proper time, of a certain agreement made with the same by the present owner of these claims and the necessary provisions could not be brought into the mountains before the first great snow storms and overflows of the season which occurred between the 15th and 20th of Nov. it was impossible to finish the work. Therefore these claims are to be considered as valid and not open for relocation. The above mentioned claims are situated in (Esper (Helen) Mining District County of Stannan State of Washington between the 1st day of Jan, 1896, and the 31st day of Dec 1896 such expenditures were made by or at the expense of A. Wold and K. Ludloff, owners of said claims for the purpose of complying with the law, and holding said claims.
