Notice of Lien.

Notice is hereby given that O. L. Irwin, Pat Heenan, Chas Webb, Nick Franz, John Marshall, Geo. M. How, Van Thomas, Pat Lyons, Tom Duff and Smith & Griggs of Skamania County, Washington, claim a lien upon a lot of cord wood, being about 700 cords in quantity, which was cut in Skamania County, Wash. and is now lying in the woods near Duller in said County, for labor performed upon and assistance rendered in cutting said wood; that the name of the owner or reputed owner is C. E. Lund; that he employed said claimants to perform such labor and render such assistance upon the following terms and conditions, to wit: claimants were to furnish tools & cut for 85¢ per cord, or Lund furnish tools & claimants cut for 80¢ per cord. Said claimants boarded themselves until Jan. 1, 1905 from which date Lund furnished a cook & grub, the claimants paying \$2.50 per week for said board. Lund agreed to pay claimants on the 20 of every month. The said C. E. Lund agreed to pay the said claimants for such labor and assistance; that the said contract has been faithfully complied with on the part of said claimants, who performed said lab. for the period of about 4 months; that said labor and assistance were so performed and rendered upon said wood between the 15th day of Nov. 1904 and the 10th day of March, 1905 and the rendition of such services were closed on the 10th day of March 1905, and thirty days have not elapsed since that time; that the accounts of said claimants demands for said services are:

O. L. Irwin, labor and supplies \$4.75. Pat Heenan, labor \$5.95. Chas Webb, labor \$3.84.
Geo. M. How, cook \$29.65, Pat Lyons labor 20.80, Van Thomas labor \$29.00, Tom Duff labor \$5.00
Smith & Griggs hauling and supplies \$21.45, John Marshall labor \$12.10, Nick Franz labor \$14.15
J. D. Griggs expense and advance costs in filing this claim \$19.00, that the above are correct balances due the respective claimants after deducting all just credits and offsets, in which amounts they claim a lien upon said wood for said balances, & to & reasonable attorneys fees for each claimant.

State of Washington, Skamania County, ss. R. M. Wright being first duly sworn on oath says, that he is the attorney for the claimants named in the foregoing claim, has heard the same read, knows the contents thereof and believes the same to be true.
