WHEREAS There has been deposited in the GENERAL LAND OFFICE of the United States a CERTIFICATE OF THE REGISTER OF THE LAND OFFICE AT Vancouver, Washington, whereby it appears that, pursuant to the Act of Congress Approved 20th May, 1862, "TO SECURE HOMESTEADS TO ACTUAL SETTLERS ON THE PUBLIC DOMAIN," and the acts supplemental thereto, the claim of Anthony Doherty has been established and duly consummated, in conformity to law, for the North West Quarter of Section Twenty-nine, in Township Two North, of Range Five East of Willamette Meridian, in Washington, containing one hundred and sixty acres. according to the OFFICIAL PLAT of the Survey of the said Land, returned to the GENERAL LAND OFFICE by the Surveyor General:

NOW KNOW YE, That there is, therefore, granted by the United States unto the said Anthony Doherty the tract of land above described: TO HAVE AND TO HOLD the said tract of Land, with the appurtenances thereof, unto the said Anthony Doherty and to his heirs and assigns forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such

water rights, as may be recognized and acknowledged by the local customs, laws, and decisions of courts, and also subject to the right of the proprietor of a vein or lode to extract and remove his ore therefrom, should the same be found to penetrate or intersect the premises hereby granted, as provided by law. TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

"WHEREAS, there has been deposited in the General Land Office of the United States a certificate numbered one hundred and fifty two of the Register and Receiver at Vancouver, Washington Territory, whereby it appears that under the provisions of the act of Congress approved the 27th day of September, 1850, entitled "An act to create the office of Surveyor General of the Public Lands in Oregon, and to provide for the survey and to make donations to settlers of the said public lands," and the legislation supplemental thereto, the claim of Daniel Baughman and his wife Elizabeth Baughman of Skamania County, Washington Territory, Notification No. 368 has been established, to a donation of one-half section, or Three hundred and twenty acres of land, and that the same has been surveyed and designated as claim number forty two, being parts of sections one, two and eleven, in Township Two North, of Range seven East, according to the Official Plat of Survey returned to the General Land Office by the Surveyor General, being bounded and described as follows, to-wit:

Beginning at a point sixteen chains West of the Meander post at the South-East corner of said section two and running thence North fifty six chains and twelve links; thence East seventy six chains and fifty links; thence South six chains and sixty three links; thence North seventy seven degrees and thirty minutes West two chains and sixty five links; thence South fifty seven degrees West two chains; thence South two chains and ten links; thence South twenty degrees and thirty minutes West three chains and seventy three links; thence South one chain and eighty seven links; thence South twenty five degrees and thirty minutes East two chains and seventy three links; thence South twenty nine degrees West four chains and fifty links; thence South seventy seven degrees and forty five minutes West three chains and fifty links; thence South forty three degrees and fifteen minutes West three chains and twenty two links; thence South sixty six degrees West three chains; thence West three chains and ten links; thence South twenty one degrees and forty five minutes West two chains and eighty three links; thence south thirty nine degrees West three chains, thence South fifty one degrees West twenty chains and twenty links; thence West one chain and twenty five links; thence South nineteen degrees West two chains and ninety links; thence South Sixty nine degrees West nine chains and thirty links, thence South twenty six degrees and forty five minutes West three chains and fifty links; thence South forty three degrees and thirty minutes West five chains; thence West two chains and sixty links; thence North seventy one degrees and fifteen minutes West three chains and forty links; thence South thirty one degrees and fifteen minutes West two chains and fifty links, thence South twenty two degrees West four chains and thirty links; thence South fifty degrees and fifteen
