Edwin C. Edwards, claimant, vs. Mt. Maaden Lumber Co.
Notice is hereby given that Edwin C. Edwards of Miles, State of Michigan claims a lien upon a quantity of saw logs being about 170000 feet in quantity, which were cut and manufactured in Stannum County State of Washington, and are now lying in the mill pond of the Mt. Maaden Lumber Company near the Town of Steunton in Stannum County, Washington, also 200000 feet of lumber, more or less, of various dimensions, being all the lumber now located and lying and stacked at or near the said mill of the Mt. Maaden Lumber Company, near said Town of Steunton, also 2000 ties, more or less, lying and being at or near the said mill and along the flume extending from said mill toward the Columbia River, for labor performed upon and materials rendered in connection with the logging of said logs and the logs from which the said ties and lumber were manufactured. That the amount of the sum requested on of the said logs, lumber and ties, is the Mt. Maaden Lumber Company; That Edwin Edwards is a subcontractor in the employ of the said Mt. Maaden Lumber Company and that the said Edwin Edwards employed the said Edwin C. Edwards to perform said labor and materials aforesaid; that said labor has been faithfully performed and fully completed with a the work of said Edwin C. Edwards, who performed labor upon and assisted in the logging of said logs; that said logs from which said lumber and ties were manufactured for a period of about five months, that said labor and materials were rendered upon said logs between the 29th of April or thereabout, and the 16th day of September 1909, and the rendition of said services was closed on the 16th day of September 1909 and thirty days have not elapsed since that time; that the amount of claimant's demand for said services is \$436.15; that no part thereof has been paid except the sum of \$50.00, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets the sum of \$386.15, which amount the claimant claims a lien upon said logs, lumber and ties. The said Edwin C. Edwards also claims a lien upon all said logs, lumber and ties now owned by the said Mt. Maaden Lumber Company of and bound to secure payment for the work and labor performed in obtaining or securing said logs, lumber and ties herein described.
