Know all men by these presents that we James Nevin, and Eliza Nevin, wife of the said James Nevin, of the County of Skamania, in the Territory of Washington for, and in consideration of the sum of One dollar to us in hand paid by William Haffey, of the same County and Territory and also in consideration, and for the purpose of dividing the tract of land hereinafter described, which was, on the twenty eighth day of April A.D. 1875, sold and conveyed to the said William Haffey, and James Nevin, by Sarah Stevenson, have granted, bargained and sold, and we do by these presents grant, bargain, sell and Convey unto him the said William Haffey and to his heirs and assigns,

The west two thirds of the following described tract of land, namely. The North half of the North East quarter and the North half, of the North west quarter of Section four, in Township one, and the South half of the South east quarter and the South half of the south west quarter of Section Thirty three in Township two. North of Range five East of the Willamette Meridian, the said tract of land being in the County of Skamania aforesaid, and containing Three hundred and twenty two 22/100 acres, and the two thirds of the said tract of land which is hereby conveyed, is to be taken in one body from the west of the said tract, running the whole width of the said tract from North to South, and two thirds of its length from West to East, and from East to West.

To have and to hold the same, withall and singular the tenements, hereditaments and appurtenances, thereon being, or thereunto in any manner appertaining or belonging, unto him the said William Haffey, and unto his heirs and assigns forever.
