QUIT CLAIM DEED

From Justin Chenoweth, to George W Phelps.

Know all men by these presents, that I Justin Chenoweth Senior, of the County of Whatcom, and Territory of Washington, in consideration of the sum of One Hundred and Fifty Dollars, to me paid by George W. Phelps, Junior, of Portland Oregon, (the receipt whereof is hereby acknowledged) do hereby convey, remise, release, and for ever Quit claim, unto the said Phelps, his heirs, and assigns a certain lot of land, situate in the County of Skamania, and Territory aforesaid, consisting of about One Acre, with all the buildings thereon standing bounded and described as follows. "Viz". Beginning at a stake on the North Bank of the Columbia River near the upper end of the Channel which devides Powder Island from the main land immediately above the Cascades

From said stake, a Balm Tree 18 inches in diameter bears N $85\frac{1}{2}$ E, 21 feet, Running thence N 38° W 286 feet to a stake set for the North corner, standing 63 feet, beyond a Maple Tree 14 inches in diameter directly on said line Thence S 52° W. 231 feet, to a stake set for the west Corner, from which a Stinkwood, or Barberry tree, 10 inches in diameter, bears, S. 40° W 15 feet distant, Thence S. 28° E. 151 feet to the Northern bank of the Chute, 10 feet beyond a Balm tree, 3 feet in diameter standing immediately on said line, Thence up the North bank of the Chute to the place of beginning.
