FROM S. M. HAMILTON & WIFE TO S. B. JONES.

This Indenture Witnesseth, that whereas, we S. M. Hamilton and Mary J. Hamilton wife of the said S. M. Hamilton of the County of Skamania in the Territory of Washington, did on the nineteenth day of March, in the year of our Lord, One Thousand Eight Hundred and Sixty Eight, execute under our Seals, and hands and deliver to Samuel B. Jones of the said County of Skamania, a Deed of conveyance whereby we in consideration of the sum of One Hundred dollars which was then and there paid to us by the said Samuel B. Jones, a certain lot or parcel of land situate in the said County of Skamania and hereinafter particularly described, and whereas the names of the witness to our respective signatures, are and were inadvertently omitted to be signed to the said deed of conveyance and the said deed now appears to have been made and executed without the requisite witnesses.
