And the parties of the first part, will at all times keep their House of worship erected or to be erected on said premises, insurance against loss, or damage by fire, in at least the sum of Two Hundred Dollars for the benefit of the parties of the second part and if they fail to do so, the parties of the second part, may at their option and at the expense of the parties of the first part, insure and Meep insured the same and the parties of the first part agree to reimburge the premiums therefor, to the parties of the second part on demand and the smae of unpaid shall be deemed secured by these presents, in addition to the and as aforesaid granted provided always and there presents are upon this express condition that so long as the parties of the first part, their successors or assigns shall well and trulyAgive nitice unto the parties of the second part, their seccessors cor assigns as herein agreed and ahall pay for said assurance, and fully keep and perform, all the terms and conditions, herein mentioned, the said parties of the first part, and the Church in connection with which they are organized, may and shall remain in possession and enjoyment of said premises andbuildings for the uses and purposes of such Evangelical Congregational Church as freely andfully as if these presents had not been executed and further that on the payment of said sum, and sums, by the parties of the first part, to the parties of the second part, their successors or assigns and on performance of all the terms and conditions herein mentioned, then these and the estate hereby granted, shall cease determine and be will provided however, and the foregoing conditions are expressly subject to the covenant, and condition hereinafter following, that the parties of the first part for themselves, their successors and assigns do covenant, and agree to and with the said parties of the second part, that in case the said parties of the first part, or their successors, or the Church in connection with which they are arganized, shall cease to be an Evangelical Congregational Church, or or shall for the space of one year suspend public worship shall cease to maintain public worship, Nor shall fails to keep their House of Worship insured against loss by fire, or shall fail to make and annual contribution to the Treasury of the American Congregational Union, or in case their Corporate exestence shall cease: on in casetheir House of Worship shall be aleinated, with out repaying to the parties of the second part their successors or assigns, thesum hereby granted or securing said sum to them, in a manner satisfactory to them, their in any such case, it shall be lawful for the parties of the second part their seccessors, or assigns , to Cuter into and upon all and singular the premises hereby granted on intended so to be, and to sell and dispose of the same and all benefit and equity of redemption of the parties of the first part their successors or assigns, therein at public auction.
