

Loggers Lien.

Eric Nord, claimant. vs. J. I. Foster.

Notice, is hereby given that Eric Nord, of Skamania County, state of Washington, claims a lien upon a number of bottomwood logs being about two hundred and fifty, in quantity, together with the boom sticks surrounding and holding the same, which were cut or manufactured in Skamania County, state of Washington, and are not marked and are now lying in a boom at or near the mouth of Blue Creek, on the tract of land of about twenty-two acres owned by E. P. Ast, about one and one half miles westwardly from the town of Stevenson, Skamania County, state of Washington, for labor performed upon and assistance rendered in getting out said logs, that the name of the owner or reputed owner is J. I. Foster, that J. I. Foster employed said Eric Nord, to perform such labor and render such assistance upon the following terms and conditions to wit:

The said J. I. Foster, agreed to pay the said Eric Nord, for such labor and assistance the sum of \$100.00 for hauling in said logs and \$10.00 per day hauling in said boom sticks; that said contract has been faithfully performed, and fully complied with on the part of said Eric Nord, who performed labor and assisted in getting out said logs and boom sticks for the period of about thirty days; that said labor and assistance were so performed and rendered upon said logs, between the 15th day of January, and the 15th day of March, 1913; and the rendition of said service was closed on the 15th day of March, 1913, and thirty days have not elapsed since that time; that the amount of claimants demand for said service is \$120.00 that no part thereof has been paid, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$120.00, in which amount he claims a lien upon said logs. The said Eric Nord, also claims a lien on all said logs now owned by said J. I. Foster of said county to secure payment for the work and labor performed in obtaining or securing said logs, claimant also claims a lien upon said logs, for the sum of \$3.00 dollars expense
