NO. 1920 } of Skamania County Washington Territory has deposited in the General
Land Office of the United States a certificate of the Register of the Land office
at Vancouver Washington Territory whereby it appears that full payment has been
made by the said Julius Ordway } According to the Provision of the act of Congress
of the 24th of April 1820 entitled an act making further provisions for the sale of
the Public Lands and the acts supplemental thereto for the South Half of the North
West quarter of Section fourteen in township three North of Range Nine East of the
Willamette Meridian in Washington Territory containing eighty acres according to
the Official Plat of the survey of the said Lands returned to the General Land of-
fice by the surveyor General which said tract has been purchased by the said Julius
Ordway } Now know ye that the United States of America in consideration of the pre-
mises and in conformity with the several acts of congress in such case made and
provided having given and granted and by these presents do give and grant unto the
said Julius Ordway } and to ---his --- heirs the said tract above described to have
and to hold the same together with all the rights, privileges, Immunities and ap-
purtenances of whatsoever nature thereunto belonging unto the said Julius Ordway)
and to his heirs and assigns forever subject to any vested and accrued water rights
for mining agricultural manufacturing or other purposes and rights to ditches and
reservoirs used in connection with such water rights as may be recognised and ac-
knowledge by the Local Customs, Laws and decisions of Courts and also subject to t
the Right of the Proprietor of a vein or Lode to extract and remove his ore there-
from, should the same be found to penetrate or intersect the premises hereby granted
as provided by law.
