Notice is hereby given that the undersigned a citizen of the United States of over the age of twenty one years has this the twenty first day of May 1883 discovered a vein or lode of quartz or sand rock in place bearing Gold, silver and lead within the limits of the claim hereby located situated in Canyon Creek District in the County of Skamania and Territory of Washington and has this the twenty first day of May 1883 located fifteen hundred linear feet of this vein or lode in length running to and from this notice at the discovery or prospect shaft with surface ground of ~~the~~ three hundred feet in width on each side of the centre of said vein or lode. Fleming, his wife of Skamania County Washington Territory, in consideration of Six Hundred Dollars to us paid by Julius Ordway of Portland Oregon the receipt whereof is hereby acknowledged do hereby grant, bargain, sell and convey to said Julius Ordway his heirs and assigns, forever, the following described parcel of real estate, to wit: The North East quarter of Section Eighteen Township Number Two North of Range Number Five East Will. Mer. containing One hundred and fifty eight acres and twenty eight hundredths. Together with the tenements, hereditaments and appurtenances thereto belonging, or in any wise appertaining and also all our estate, right, title, and interest, at law and equity therein or hereunto, including dower and right of dower.

To have and to hold the same of the said Julius Ordway his heirs and assigns forever. And we do covenant with the said Julius Ordway and his legal representatives, forever, that the said real estate is free from all incumbrances, and that we will, and our heirs, executors and administrators, shall warrant and defend the same to the said Julius Ordway his heirs and assigns forever, against the lawful claims and demands of all persons whosoever.
