Fleming, the said logs are worth more, and in no case shall the price paid exceed fove Dollars (\$5.00) per thousand feet.

The said J. Ordway & Co, Hereby agree to advance supplies to the said John G. Fleming and the value of the supplies so furnished shall be decucted from the payment for logs, and the said J. Ordway & Co loans to the said John G. Fleming two, yoke (four head) of Oxen the value said Oxen is agreed to be seventy-five (\$75) per head.
