The South west quarter of Section Fourteen in Township three, North of range nine East of the Willamette Meridian in Skamania County, Washington Territory and containing one hundred and sixty acres. Together with the tenements, hereditaments and appurtenances thereto belonging, or in any wise appertaining: and also all our estate, right, title, and interest, at law and equity therein or thereto including dower and right of dower. To have and to hold the same to the said Julius Ordway his heirs and assigns, forever, and we the said William J. Snyder and Jennie A. Snyder do covenant with the said Julius Ordway and his legal representatives forever, that the said real estate is free from all incumbrances, and that we will, and our heirs executors and administrators, shall warrant and defend the same to the said Julius Ordway his heirs and assigns, forever, against the lawful claims and demands of all persons whatsoever.
